D. ADDITIONAL COMMENTS TO SUPPORT JD: Project manager visited the site on 9/25/2015. This property has been heavily disturbed by past mining activities and subsequent placement of fill. No streams or wetland have been found. The feature in question was clearly excavated to direct stormwater flow away from the adjacent car junkyard. It is a very small channel that begins at the property boundary and continues east through a forested area, then it turns north along the railroad tracks and ends a little bit further north. This ditch does not connect to another water and ends next to the tracks where water percolates through the soils. In addition to being a (b)(3)(iii) feature, it is also a (b)(3)(i) feature as it only contains ephemeral flow from stormwater and it does not relocate a stream.

¹ In many cases these excluded features will not be specifically identified on the approved JD form, unless specifically requested. Corps Districts may, in case-by-case instances, choose to identify some or all of these features within the review area.
