Rationale for Basis (applies to any boxes checked above): Silver Creek flows through the subject site, to Nippersink Creek, and to the Fox River, a navigable waterway. Wetland 3 in the Delineation Report dated January 9, 2006, as prepared by Raisanen & Associates, Inc., includes Silver Creek and part of ADID High Functioning wetland #N948. We concur with the boundary of the jurisdictional Wetland 3. Wetland 1 and Wetland 2 in the report are farmed wetlands located on the eastern portion of the subject site. However, a NRCS certified farmed wetland determination on May 2, 2001, indicating that there are actually four farmed wetlands totalling 3.2 acres. The four NRCS farmed wetland appear to be isolated, and not under Corps jurisdiction.
