The feature in question is an intermittent tributary / wetland swale that drains north through the subject property. This area is within the Rush Creek watershed. A review of available resources indicates that there is no hydrological connection between the subject wetland and area jurisdictional waters.

Water drains north to a large wetland area to the north. The wetlands were investigated for potential flow routes to the north, east, and west. The two-foot contour map indicates that the wetland that the subject feature drains to is confined to a closed depression at an approximate elevation of 870 feet. For flow to continue naturally, the elevation of the water would have to rise to 884 or higher for flow to the east or north. To flow west, it would have to rise to 874, but there was no evidence of typical flow occurring in that direction from this wetland. There appears to be an overland drainage route to the west based on the contours, but again, there are no indications of flow on the aeriels.

Further review of additional maps confirms the determination. The area is outside of the 100-year floodplain, there is no hydric soil route to jurisdictional waters, and the USGS topographic maps shows the intermittent tributary end at the isolated wetlands to the north. Additionally, a site inspection under LRC-2001-10611 entered into the database on May 3, 2001 by Kara Hellige listed the following: ¿Area experiences drainage from the south - no outlet present. I did not see any pipes or channels that would connect the wetland. I believe the area is isolated.¿

Based on the above, the subject wetland / intermittent tributary would be considered isolated.
