Wetland in question abutts the tributary offsite and drains to the tributary through an on-site drop structure and pipe.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: Site visit Nov 16, 2017 determined that wetland area drained through structure within wetland at north west corner of the site (adjacent to 63rd Street). Drainage was tracked east and north to outfall into South Branch Marion Street Ditch which is tributary to Flagg Creek and thence to the Des Plaines River. This flow appeared to be frequent/constant. Wetland area appears to also drain directly to the South Branch Marrison Hills Ditch when water levels are elevated.

Summarize overall biological, chemical and physical functions being performed: Wetland 2 has a discernible stormwater pipe which carries water from the wetland into Saw Mill Creek which is an RPW and eventually drains into Plum Creek. Wetland 3 drains into a channel which is carried under I-394 and into a roadside ditch along the southern side of Burville Road which eventually drains directly into Plum Creek. Plum Creek has Relatively Permanent Flow and exhibits a direct surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. The adjacent wetlands have the ability to reduce the amount of pollutants and floodwaters reaching the TNW. The headwater wetlands are receiving a percentage of its water from groundwater and from runoff from the surrounding uplands before it flows into the Little Calumet River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The decrease of sedimentation, pollutants, flooding, nutrients and habitat provided by the subject wetland provides a positive effect to the downstream relatively permanent waters and traditional navigable waters. The wetlands alone, and in combination with other area wetlands, significantly affect the chemical, physical and biological integrity of the Little Calumet River. Stomwater storage provided by the subject wetlands affect the frequency and extent of downstream flooding, decreasing flood peaks in the Little Calumet River, and in turn impacting navigation and downstream bank erosion and sedimentation. The sediment and pollutant/toxicant retention provided by the subject wetland has a direct positive effect on the Little Calumet River in regards to navigation and aquatic food webs that are not adapted to thrive in sediment-choked environments. These factors contribute to the finding of a significant nexus between the on-site wetland and the TNW.
