It was determined through the consultants submittal and a filed visit that the marsh (Wetland 1) was jurisdiction because of it's connection to Fraction Run Creek through an unnamed tributary that runs through the golf course south of the project area directly connecting to Fraction Run. Additionally, the portion of Road Ditch 4 is directly connected with the marsh, with no obvious separation between the ditch and the marsh as water from the marsh, flows directly south into Road Ditch 4 and continues south through a culvert which takes the water onto the golf course property and eventually to Fraction Run.
