C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Findings for: Wetland 1, Wetland 2

Wetland 1 (approx. 0.44 ac.) was originally a part of wetland 2 (approx. 0.08 ac.), and was excavated for an in-stream pond; therefore I will address both together. Both waters continue out through the tributary not excavated and off-site, which has seasonal relative permanent flow to the East Branch DuPage River. The East Branch DuPage River is a Relatively Permanent Water, and flows into the DuPage River which exhibits a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. These waters have the ability to reduce the amount of pollutants and floodwaters reaching the TNW. The headwater pond receives a percentage of it's water from groundwater and from runoff from the surrounding uplands before it ultimately flows into Des Plaines River. Waters such as these provide stormwater storage, habitat, sediment/toxicant retention

and nutrient removal/transformation. The decrease of sedimentation, pollutants, flooding and nutrients, and habitat provided by the subject wetland provides a positive effect to the downstream relatively permanent waters and traditional navigable waters. These waters alone, and in combination with other area wetlands, significantly affect the chemical, physical and biological integrity of the Des Plaines River. Stormwater storage provided by the subject pond affects the frequency and extent of downstream flooding, decreasing flood peaks in the Des Plaines River, and in turn impacting navigation and downstream bank erosion and sedimentation. The sediment and pollutant/toxicant retention provided by the subject pond has a direct positive effect on the Des Plaines River in regards to navigation and aquatic food webs that are not adapted to thrive in sediment-choked environments. These factors contribute to the finding of a significant nexus between the on-site waters and the TNW.

The wetland drains out through a roadside ditch to the east, and then to the south, which then enters Thorn Creek, which has relative permanent flow, and exhibits a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. This wetland has the ability to reduce the amount of pollutants and floodwaters reaching the TNW. The headwater wetland is receiving a percentage of it's water from groundwater and from runoff from the surrounding uplands before it flows into Thorn Creek. Wetlands such as these provide stormwater storage, habitat, sediment/toxicant retention and nutrient removal/transformation. The decrease of sedimentation, pollutants, flooding, nutrients and habitat provided by the subject wetland provides a positive effect to the downstream relatively permanent waters and traditional navigable waters. The wetland alone, and in combination with other area wetlands, significantly affect the chemical, physical and biological integrity of the Little Calumet River. Stormwater storage provided by the subject wetland affects the frequency and extent of downstream flooding, decreasing flood peaks in Thorn Creek, and hence the Little Calumet River, and in turn impacting navigation and downstream bank erosion and sedimentation. The sediment and pollutant/toxicant retention provided by the subject wetland has a direct positive effect on the Little Calumet River in regards to navigation and aquatic food webs that are not adapted to thrive in sediment-choked environments. Both tributaries along the property boundary exhibited strong flows and flooding based on debris in channels and matted vegetation; and were in deeply incised cuts. Both tributaries were lined with trees, shrubs and herbaceous vegetation, and merged at the corner of the property and continued flowing off-site. Both channels were anywhere from 2-10 feet wide, and had a foot or more of water at the time of my visit; and both were flowing continuously. The tributaries have seasonal relative permanent flow, and exhibit a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributaries to carry pollutants, flood waters, nutrients and organic carbon to the TNW. These tributaries with scattered adjacent wetland pockets provide stormwater storage, habitat, sediment/toxicant retention and nutrient removal/transformation. The decrease of sedimentation, pollutants, flooding, nutrients and habitat provided by the tributaries provides a positive effect to the downstream relatively permanent waters and traditional navigable waters. The nature of these tributaries significantly affects the chemical, physical and biological integrity of the Des Plaines River. Stormwater storage provided by the subject tributaries and riparian wetlands affect the frequency and extent of downstream flooding, decreasing flood peaks in the Des Plaines River, and in turn impacting navigation and downstream bank erosion and sedimentation. The sediment and pollutant/toxicant retention provided by the tributaries and riparian wetlands has a direct positive effect on the Des Plaines River in regards to navigation and aquatic food webs that are not adapted to thrive in sediment-choked environments. These factors contribute to the finding of a significant nexus between the on-site wetland and the TNW.
