The wetland complex extends beyond the project to the south where it directly connects with the north side of Crystal Lake. Wetland 1 was delineated as distinct from Wetlands 2 and 3 but these wetlands due to their size and position in the landscape combine to provide significant water quality and ecological functions. As such, these wetlands are viewed collectively to be one complex that directly abuts Crystal Lake.**

Water likely flows in this ditch year round based on the fact that it was flowing (2-4 inches deep at Route 31) in September and based on previous observations over the last several years in the area that water is generally present and flowing along this ditch. Based on the persistence of this flow the ditch likely intersects with the groundwater table. The ditch itself is a non-jurisdictional roadside ditch. Wetland 2 is located at Half Mile Trail and IL-31 with the roadside ditch flowing along it. The ditch continues south along the west side of IL-31 and turns east and through a culvert under Route 31. Water flow continues off-site on the east side of IL-31 into a large wetland complex associated with Sleepy Hollow Creek, a RPW tributary to the Fox River, a TNW .**
