Water was observed flowing from the pond to the wetland. The small pond is visibly connected to the wetland and appears to have been constructed within this wetland. Water flows in a ditch that is clearly visible through and along the wetland that conveys water southeast along I-90. 1-foot contours demonstrate positive drainage. Water flows in this ditch for approximately 2000 feet before entering the tributary to Higgins Creek. This 2000 foot segment of ditch may be within a wetland, however it was located off-site and was not investigated. At this point, the tributary flows under I-90 and continues as a blue-line stream on the USGS map. The flow route continues from the tributary to Higgins Creek, to Higgins Creek, to Willow Creek, to the Des Plaines River. The Des Plaines River becomes a TNW south of the former Hoffman Dam..

Summarize overall biological, chemical and physical functions being performed: The wetland is adjacent and contiguous to the tributary to Trail Creek, which has seasonal relative permanent flow, and exhibits a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. Summarize overall biological, chemical and physical functions being performed: This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. The adjacent wetlands have the ability to reduce the amount of pollutants and floodwaters reaching the TNW. The headwater wetlands are receiving a percentage of its water from groundwater and from runoff from the surrounding uplands before it flows into Des Plaines River. Wetlands such as these provide stormwater storage, habitat, sediment/toxicant retention and nutrient removal/transformation. The decrease of sedimentation, pollutants, flooding, nutrients and habitat provided by the subject wetland provides a positive effect to the downstream relatively permanent waters and traditional navigable waters. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Summarize overall biological, chemical and physical functions being performed: Wetlands 1 & 2 are adjacent and contiguous to the storm sewers connected to the tributary to Indian Creek, which has seasonal relative permanent flow, and exhibits a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW. The adjacent wetlands have the ability to reduce the amount of pollutants and floodwaters reaching the TNW. The headwater wetland is receiving a percentage of its water from groundwater and from runoff from the surrounding uplands before it flows into Fox River. Wetlands such as these provide stormwater storage, habitat, sediment/toxicant retention and nutrient removal/transformation.
