Summarize overall biological, chemical and physical functions being performed: The wetland is adjacent and contiguous to the tributary to the I&M Canal, which has seasonal relative permanent flow, and exhibits a surface water connection to a traditional navigable waterway. This surface water connection demonstrates the ability of the tributary to carry pollutants, flood waters, nutrients and organic carbon to the TNW.
