Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Wetland 1 and Wetland 2 total 1.8 acres in size and are depressional wetlands. They drain southeast and not to Blackberry Creek. It would appear they would be part of a drainage of an unnamed tributary to the Fox River that is parallel to Blackberry Creek. They are almost 6,000 feet from a drainage visible on the USGS topographic map, and almost 5,000 feet of the blue line area is now either overland flow or below ground in drain tile. There is over 2 miles between this wetland complex and an actual visible stream above ground.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

The subject wetland drains south through a wooded area and across an agricultural field through a swale for approximately 0.5 miles. It is not known what portions of this swale could be considered wetland. A culvert is present under Harmony Hill Road which can convey water from the east to the west side of the road. No water was observed within the swale at the time of the site visit.

Standing water is present on the west side of the roadway and this appears to be the beginning of an intermittent or RPW at this point. This waterway is tributary to Coon Creek approximately 3.4 miles to the south and west. The USGS 10-foot topographic map identifies the tributary to Coon Creek as an intermittent tributary beginning a short distance east of Ridge Lane. It becomes a solid blue line on the USGS map at Coon Creek.

Coon Creek is tributary to the Kishwaukee River, which is tributary to the Rock River, a TNW. The Rock River is over 20 miles from the site. Water drains from the on-site wetland and potentially reaches regulated waters, creating a nexus to jurisdictional waters.

Additional supporting material leads to a conclusion of no significant nexus, as summarized below. The USDA soil survey maps only indicate the presence of hydric soils for a portion of the drainage swale from the subject wetland to the culvert at Harmony Hill Road. Mapped 100-year floodplain begins approximately 2.3 miles downstream along the tributary to Coon Creek. The hydrologic atlas indicates the flood of record reaching near Harmony Hill Road, but not east of it. This is more than 0.5 miles downstream of the subject wetland. A review of the National Wetland Inventory and the McHenry County ADID maps do not indicate the presence of wetlands in the location of the subject wetland or along the swale through the agricultural field to the south.

The information presented leads to the conclusion that a significant nexus does not exist between the subject wetland and jurisdictional waters. This review indicates that jurisdiction likely begins west of Harmony Hill Road, approximately 0.5 miles south of the subject wetland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
