- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: **Site W1 falls in line with the general footprint of the stormwater detention facility in the old plans, so this area would not be regulated. This basin ties into a drainage swale to the north (S-2). S-2 is a conveyance for stormwater runoff and does not appear to historically be wetland, so it would also be a non-regulated feature.**

**Pond 1 is an historic stormwater facility and would not be regulated.**

**The area around data point P3 was investigated. This area was part of a failed mitigation project for a previous Corps permitted project. A mix of vegetation was observed, tending towards hydrophytic. Areas of standing water were observed, but heavy rainfall occurred in the days leading up to the site visit. The delineation report indicated an absence of hydric soils. Although some wetland characteristics were present, the area did not meet the three criteria to be considered a wetland.**

**The ditches S-1 and S-1a appear to be dug in uplands (the eastern portion of the ditch is mapped hydric) and function to transport stormwater, so these features would not be regulated. Ditch S-1a conveys stormwater runoff from Willow Springs Road and S-1 takes water from a small PVC pipe. A low flow of water was observed exiting the pipe with a sudden higher surge also observed indicating that this pipe is likely partially fed by sump pump discharges from buildings in the area.**

**Site W3 is perched upon apparent historic fill on the 10-acre parcel. This wetland is a closed depression with no connection to Site W2. Therefore, this wetland is isolated..**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
