- Area(s) are geographically isolated.
- Area(s) do not have a hydrologic nexus. Areas have no surface water connection and no known drain tile connection. The three areas on the east of the site (Wetland 3, Wetland 2, and Borrow Pit 5) appear to have an artificial grassed waterway connection to a partially developed site to the east that was graded from 2005-2007, and contains new road side ditches that did not previously exist.
- Area(s) do not have an ecological nexus. The wetlands and pond in question are farmed and have little ecological quality.
- Area(s) do not have evidence of a subsurface flow connection to a jurisdictional water. Wetland 1 and Farmed Wetland 2 do not have a drain tile connection on the drain tile survey for that property. The three areas on the east of the property have no known drain tile connection..
 - Area(s) do not have evidence of surface overland sheet flow. Wetland 1 appears to have approximately 1,000 feet of overland sheet flow to White's Creek in very wet aeriels. Farmed Wetland 2 appears to have partial overland sheet flow to White's Creek in very wet aeriels. Borrow Pit 5 with Wetland 2 and Wetland 3 may have 1,250 feet of overland flow to a man made ditch system (constructed in uplands) to the east. .

Stormwater storage provided by the subject wetland affect the frequency and extent of downstream flooding, decreasing flood peaks in the I&M Canal, and in turn impacting navigation and downstream bank erosion and sedimentation. The sediment and pollutant/toxicant retention provided by the subject wetland has a direct positive effect on the I&M Canal in regards to navigation. These factors contribute to the finding of a significant nexus between the onsite wetland and the TNW..
