This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Pond 4 occasionally drains into a storm pipe that leads to the East Branch DuPage River, which has seasonal relative permanent flow, and exhibits a surface water connection to a traditional navigable waterway. Although this surface water connection demonstrates the ability of the storm system to carry pollutants, flood waters, nutrients and organic carbon to the TNW; Pond 4 lacks a significant nexus to the TNW given it only overflows into the storm sewer system during large rain events that exceed the capacity of the Pond.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The water only flows out of Pond 4 during high rain events; and had some minor outflow at the time of my visit due to recent snowmelt due to seasonably warm weather. Lacking that snowmelt, this pond would not drain out at all during winter like Pond 6 does (for comparison). These factors contribute to the finding of a lack of a significant nexus between the on-site Pond and the TNW.

Given the ephemeral nature of the connection of this small wetland to the larger wetland complex to the east, it does not significantly affect the habitat or lifecycle support functions for habitat in the TNW, or transfer nutrients or organic carbon beyond the larger wetland complex to the east, or affect the physical, chemical or biological integrity of the TNW, and therefore lacks a significant nexus.**
