C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The estimated 2.5 acres of wetlands along the road are not contiguous, abutting, nor adjacent to any RPW. The hydric soil series in which this wetland lies does not connect to any creeks. There is upland soil between this wetland and the 2 nearest creeks. The ADID Map and the NWI map do not show this area connecting to anything. The wetlands are not in nor near a floodplain. The USGS topographic map does not indicate any waterbodies, streams, nor depressional areas at this location. South of the road is a higher elevation than the north side of the road. Just north of the northeastern portion of the wetland there is a hill. The ADID map shows a purple polygon here, which indicates there is likely a wetland here that is not of high quality, please note the ADID map is not known for having accurate boundaries and tends to be a bit overmapped.
