Explain: **There is no observed connection from Wetland 1 to the remnant wetland to the north (entombed in industrial development and with no obvious outlet of its own) or the constructed basin to the south (berm between the two areas). There is no observed connection to the rudimentary ditches along the access road that borders the site on the north, these are also largely depressional, overflowing into the entombed offsite wetland previously mentioned. This entire area (onsite and off) has been historically manipulated for industrial development, everything appears to have been graded at some point. Topographic relief for the entire area is very limited, pretty much graded flat and drained in the historic past. There are storm sewers in the area that are likely to drain to 71st St Ditch, but there is no observed connection between Wetland 1, the roadside ditches, or the remnant offsite wetland to any storm sewer.**

Wetland 1 is a remnant depression that does not have an obvious drain, probably associated with the construction of a power pylon. The ditches were constructed to serve the access road and some of the gravel pads and are exempt. Wetland 1 is isolated.

Explain: **WL2 is a 0.07 acre, emergent wetland that is located on the toe of a slope and may be incidental to grading that has occurred in the area in the past. It has no visible hydrologic connection to Grant Creek and no subsurface drainage connections either. WL4 is a 0.68 acre scrub shrub wetland that was most likely a product of grading, and placement of spoil pile areas impeding drainage from the wetland area in the past. It has no visible hydrologic connection to Waters of the U.S. and no subsurface drainage connections. WL5 is a 0.66 acre emergent wetland that is most likely a product of grading and placement of fill material in the wetland in the past. It has no visible hydrologic connection to Waters of the U.S. and no subsurface drainage connections. None of the wetland features are considered High Quality Aquatic Resources. Offsite WL1 is a 0.10 acre, emergent wetland. It has a connection to Grant Creek, that upon investigation shows to not carry flow intermittently, nor does it have substantial drainage to consider it to have a significant nexus to Grant Creek.**
