Explain: **The subject wetland abuts a roadside drainage ditch that goes into a storm sewer. Storm sewer maps show that the water heads north, then west, and exiting into the Fox River. However, based on a review of GIS aerial photos and Google Earth photos, as well as a site visit after heavy rains and flooding, it was determined that the site only drains during these extreme rain events, and not afterwards. Furthermore, given the extremely small drainage area of**

the site, and the factors above, the wetland lacks a significant nexus connection to the Fox River even though there is a physical connection via storm sewers.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Wetland 1 forms at the base of a slope of an approximate 5 acre parcel in an industrial/commercial park area, and receives run-off from the site, and impounds, forming an emergent wetland on the east portion and a wooded wetland on the west portion. The wetland is small in size and provides some localized stormwater storage, sediment/toxicant retention and nutrient removal/transformation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The bulk of rainwater falling on the parcel is captured by the subject wetland, and impounds on-site with little or no flow off-site. Although the subject wetland provides localized functions and abuts a roadside ditch that exits only on the subject parcel which drains into the storm sewer system, water only leaves the site during extreme rain events. The combined inputs of water from multiple developed parcels give a cumulative flow in the storm sewer system on a more intermittent basis; however, water from this site only contributes to that flow during those extreme rain events with heavy rainfalls which are enough to have water leave the site. Given the infrequent flows off-site into the storm sewer system, the on-site wetland lacks a significant nexus connection to the Fox River (TNW).
