Explain: **Wetland 1 was identified at the corner of Reed Road and Route 47 as an herbaceous wetland. The wetland is a small depressional area located in a farm field and entirely surrounded by upland. The wetland collects stormwater from the adjacent upland and from the road. A pipe directing stormwater from the road into the wetland was identified on site but no outlet was found. Adjacent topography suggests the wetland collects water but water does not exit the site through a pipe or conveyance. The closest tributary is located approximately 1,200 feet to the north.**
