Features were also check with the county wetland maps, soils maps, hydrologic atlas maps, elevation maps, and historical aerials back to 1939. Wetland 2 is a small (0.42ac) depressional pocket of shallow emergent wetland in the middle of several farm fields. Wetland 3 (1.55 ac) is in a depressional feature in the middle of a farm field. Wetland 5 (2.25 ac) is a shallow emergent wetland on the western edge of a farm field. Wetland 7 (3.03 ac) is a large depressional feature consisting of forested wetland around a small open water pocket and cattails, and is located in the middle of a farm field. Wetland 8 (2.57 ac) is a closed depressional forested wetland that takes water from the north, ponds and evaporates. Farmed Wetland 10 (0.57 ac) is a shallow wet feature in a farm field that ponds and evaporates. Farmed Wetland 11 (1.09 ac) is a shallow depressional feature that ponds up against the hedgerow on the west site, and evaporates. Farem Wetland 12 (1.01 ac) is a closed isolated shallow depression in the middle of a farm field. Farmed Wetland 13 (0.73 ac) is a barely discernable shallow depression in the farm field.
