greater in elevation to overcome to enter Wolf Road Prairie to the east; and there are several blocks within the ditch in the prairie that would have to be topped prior to water crossing under Wolf Road and into the storm sewer line leading to Salt Creek..

B. ADDITIONAL COMMENTS TO SUPPORT JD: Historically, this area was a headwater wetland connected by a swale that would convey water in large storm events; however, there are several topographic humps in the historic drainageway to impound water on the adjacent wet-prairie site; and the wetland was excavated into a pond which is pumped automatically over the watershed break and into a storm sewer which eliminates drainage into the historic outlet; therefore the site is considered isolated and non-jurisdictional.

wetland was reported as being constructed for stormwater detention from the applicant. This appears to be true based on the review of the maps. The hydric soils map shows no hydric soils within the subject property. There appears to be no hydrologic connection from the wetland on the subject property to the closest RPW, a tributary to the Kishwaukee River, to the east. The McHenry County ADID maps do not indicate any wetlands in the project area. For the above reasons, the subject wetland has been determined to be geographically isolated and not regulated under the Clean Water Act.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Reviewing the 2' topographical contours, it is apparent that the wetland is accepting drainage from a roadside swale. Water is flowing from the north through the roadside swale and then into the wetland. The bottom of the wetland is at the 838' elevation. The roadside swale directly to the west of the wetland is at the 850' elevation. The wetland was reported as being constructed for stormwater detention from the applicant. This appears to be true based on the review of the maps. The hydric soils map shows no hydric soils within the subject property. There appears to be no hydrologic connection from the wetland on the subject property to the closest RPW, a tributary to the Kishwaukee River, to the east. The McHenry County ADID maps do not indicate any wetlands in the project area. For the above reasons, the subject wetland has been determined to be geographically isolated and not regulated under the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
