Explain: **Wetland 1 (only wetland on site for which review was requested) does not have a surface connection to a navigable water of the United States. Area around Wetland 1 was developed into an office park in the early 1980s at which time a small wetland was mapped in this area. Wetland 1 receives runoff from the adjacent parking lot and has increased in area (0.03 ac to 0.14 ac) since the site was developed. At the April 7, 2016 site visit Wetland 1 appeared to have a drainage from the wetland area into a nearby stormsewer. Applicant asserted that this drainage was due to a leaking watermain under Wetland 1. Applicant repaired the structure and asked the Chicago District to conduct a jurisdictional determination under the current site conditions. Applicants agent documented the site during several heavy rain events and a second site visit was conducted on June 23, 2016. Since the watermain repair there has been no evidence of water flowing out of this system, either into the nearby stormsewer or in any other direction. It is the conclusion of the Chicago District that this area is a non-jurisdictional isolated water.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 1 meets all the criteria for a wetland and is located in an area of mixed hydric and upland soils, the area itself is in mapped upland soils. The area is approximately 0.25 miles from the Middle Fork North Branch Chicago River (closest TNW) as the crow flies. Local drainage is to the north and east rather than directly east to the Middle Fork.
